

CYNGOR CYMUNED LLANEGRYN

Cofnodion o Gyfarfod o'r Cyngor a gynhaliwyd Nos Lun, Tachwedd 18fed 2024 am 7.30yh yn y Neuadd, Llanegryn.

Presennol; Cyng. Alwyn Roberts, Lona Harris, William T Davies, Catrin Rutherford, Eurgain Haf Davies, WRP Jones, Rhys W Williams, Beth Lawton (Cyngor Gwynedd) a Huw T Jones (Clerc)

1. Estynwyd groeso cynnes i bawb gan y Cadeirydd Alwyn Roberts.

Estynwyd groeso arbennig i Cyng Rhys Wyn Williams oedd yn mynychu ei gyfarfod cyntaf.

Gwahoddwyd ddatganiadau o ddidordeb am faterion ar yr agenda. Nid oedd unrhyw ddatganiadau.

2. Cyflwyniadau gan aelodau o'r cyhoedd ar fater ar yr Agenda.

Nid oedd unrhyw aelodau o'r cyhoedd yn bresennol.

3. Cadarnhawyd gofnodion y cyfarfod a gynhaliwyd ar y 30ain o Fedi ar gynnig Cyng. Eurgain Haf a'i eilio gan Cyng Lona Harris.

4. Materion yn codi a materion eraill.

a) **Neuadd Llanegryn**, nodwyd y diweddaraf, ac roedd e-bost Heather Black dyddiedig 11eg o Dachwedd wedi ei yrru i bob Cynghorydd. Cytunwyd â'r cynnwys. Cytunodd Cyng Eurgain Haf Davies i gynrychioli Cyngor Cymuned Llanegryn ar Bwyllgor y Neuadd. Holwyd beth fyddai posibilrwydd cael yswiriant i'r ymddiriedolwr, (sef yr holl Gynghorwyr) a byddai y Clerc yn ymholi erbyn cyfarfod nesaf.

b) **Gardd Goffa** – adroddwyd am y datblygiadau yn ddiweddaraf, a thrafodwyd y canlynol;

- Yr angen am giât arall i'r safle - nodwyd fod hyn wedi ei gytuno, ond na fyddai yn bosib ei rhoi yno fel yr oedd yr Ardd wedi eu chynllunio. Byddai y Clerc yn danfon e-bost at Mr W Willimas – Wynne yn egluro y sefyllfa, ond hefyd yn ceisio datgan fod y Cyngor am gadw yr hawl mynediad yno i'r dyfodol.
- Trafodwyd fod angen cynllun i ddangos ymhle yn union mae bwriad cychwyn gosod y placs sy'n cofnodi enwau claddu llwch. Roedd angen cadw ir un maint.
- Angen rhoi plac ar y garreg a dyddiad agor yn swyddogol – awgrymwyd Nos Lun y 23ain o Fehefin 2025 fel dyddiad posib i agoriad swyddogol. Hyn i'w drafod eto. Hefyd roedd angen arwyddion i gyfeirio pobl i'r Ardd Goffa.

- Mainc ar y safle – diolchwyd unwaith eto i Elaine Anikey am y cynnig caredig o'r Fainc. Awgrymwyd y gellid ei harchebu pan yn dymuno, a'i gosod erbyn y Gwanwyn.
- Trin a gwastadhau y tir /tirlunio – dywedodd Cyng Rhys Williams y byddai yn chwistrellu round-up yno. O ran plannu daffodils – addawodd Cyng Alwyn Roberts gysylltu efo Shan i gael y daffodils a threfnu i'w plannu oddiamgylch y safle. Byddai'r Clerc yn danfon neges i bawb i ddweud yr amser/dyddiad.

Yn dilyn trafodaeth, ac ar gynnig Cyng Eurgain Davies a'i eilio gan Cyng WRP Jones, penderfynwyd na fyddai modd claddu llwch yn yr Ardd Goffa mewn man penodol, ond yn hytrach ei chwalu ar y safle.

- c) **Llwybr sy'n arwain at y cae chwarae** – cytunwyd y dylid cael map gan y Gofrestrfa Tir, a chytunwyd i gynnig caredig Shan i gael hyn am oddeutu £45.
- d) **Cyflwr ffordd ddi-ddosbarth o Roslefain i gyfeiriad y Ffordd Ddu** – darllenwyd ymateb Adran Briffyrdd Cyngor Gwynedd. Ar gynnig Cyng William Davies a'i eilio gan Cyng Eurgain Haf, cytunwyd â'r awgrym i gael Gorchymyn i gau y ffordd i drafnidiaeth dros dro am 18 mis.
- e) **Cynrychiolydd Un Llais Cymru** – cytunodd Cyng. Lona Harris i hyn, a byddai'r Clerc yn gadael iddynt wybod.
- f) Cwynion fod y gwrych ar ochr chwith y ffordd wrth deithio i mewn i Lanegryn o'r briffordd A493, sef gyferbyn a mynediad yr ysgol tuag at fynediad ystad Maesegryn – nodwyd fod hyn wedi ei wneud.

5. Materion Cynllunio

Roedd un cais wedi ei ddsbarthu ers y cyfarfod diwethaf, sef;

6. Materion Cyllid.

- a) Cyfrifon 2023-24 – nid oedd dim datblygiad pellach.

Cadarnhaodd y Clerc fod rhan gyntaf y cais am ad-daliad TAW wedi ei wneud, a bod £3103.20 i law. Roedd y TAW ar ail ran taliad GT Davies & Co bellach wedi ei ddanfon.

- b) Anfonebau i'w talu.

- **Yswiriant y Cyngor – Zurich** - dyddiad adnewyddu 2.12.24. Ar gynnig Cyng Catrin Rutherford a'i eilio gan William Davies cytunwyd i dalu y swm dyledus o £280. Roedd yr holl ddogfennau yswiriant wedi eu danfon i'r Cynghorwyr

18.11.24 yn rhoi gwybodaeth llawn am y 'cover' sydd i'r Cyngor. Gofynnwyd i'r Clerc geisio cael cost ychwanegu yr Ardd Goffa i'r polisi.

- Ar gynnig Cyng Catrin Rutherford a'i eilio gan William Davies cytunwyd i dalu £30 i Cyng Eurgain Haf , sef cost y blodau i Shan yn y cyfarfod diwethaf.

c) Ystyried unrhyw geisiadau am arian

- **Ambiwllans Awyr Cymru** - penderfynwyd peidio cyfrannu am y tro.
- **Yr Urdd – Apel Cronfa Cyfle i Bawb** – penderfynwyd peidio cyfrannu.

d) Trafodwyd os oedd unrhyw Gynghorydd yn awyddus i hawlio treuliau/costau am 2024-25, ac roedd pawb yn unfrydol nad oeddynt am hawlio.

e) Ystyriwyd **cyllideb ddrafft** ar gyfer y flwyddyn ariannol 2025-26, a chytunwyd gan wneud mân newidiadau.

Ar gynnig Cyng William Davies a'i eilio gan Cyng Rhys Williams, cytunwyd yn unfrydol codi y praesept £700 ar gyfer 2025-2026 (i gyfanswm o £7850).

a) Dyddiadau hyfforddiant Un Llais Cymru – byddai y Clerc yn eu dosbarthu.

b) Cynhadledd Un Llais Cymru a'r SLCC ar yr 20fed o Dachwedd – dywedodd y Clerc ei fod yn cymryd rhan yn hyn ar zoom. Ar gynnig Cyng William Davies a'i eilio gan Cyng Rhys Williams cytunwyd i dalu chwarter y gost – sef £19 (gan fod y Clerc yn gyfrifol am 4 Cyngor)

c) Gohebiaeth Cyngor Cymuned Llanystumdwy ynglyn ag Adroddiad y Comisiwn Cymunedau Cymraeg – byddai'r Clerc yn ei ddosbarthu.

d) Llythyr gan bwyllgor Achub Plas Tanybwllch yn gofyn am gefnogaeth – gwelwyd fod hwn tu allan ein hardal, ond y dylem ddymuno yn dda iddynt.

e) Nodwyd ymgynghoriad gan Cyngor Gwynedd ynglyn ag Arolwg Ffiniau Cymunedol.

LLANEGRYN COMMUNITY COUNCIL

Minutes of a Council Meeting held on Monday evening, November 18th 2024 at 7.30pm in the Hall, Llanegryn.

Present; Cllr. Alwyn Roberts, Lona Harris, William T Davies, Catrin Rutherford, Eurgain Haf Davies, WRP Jones, Rhys W Williams, Beth Lawton (Gwynedd Council) and Huw T Jones (Clerk)

1. A warm welcome was extended to everyone by Chairman Alwyn Roberts.

A special welcome was extended to Cllr Rhys Wyn Williams who was attending his first meeting.

Expressions of interest were invited for issues on the agenda. There were no declarations.

2. Presentations by members of the public on an issue on the Agenda.

No members of the public were present.

3. The minutes of the meeting held on the 30th of September were confirmed on the proposal of Cllr Eurgain Haf and seconded by Cllr Lona Harris.

4. Matters arising and other matters.

a) Llanegryn Hall, the latest was noted, and Heather Black's email dated 11th November had been sent to all Councillors. Agreed with the content. Cllr Eurgain Haf Davies agreed to represent Llanegryn Community Council on the Hall Committee. It was asked what would be the possibility of getting insurance for the trustees, (which are all the Councillors) and the Clerk would inquire by the next meeting.

b) Memorial Garden - the most recent developments were reported, and the following were discussed;

- The need for another gate to the site - it was noted that this had been agreed, but that it would not be possible to put it there as the Garden had been planned. The Clerk would send an email to Mr W Willimas – Wynne explaining the situation, but also try to state that the Council wants to keep the right of access there for the future.

- It was discussed that a plan is needed to show exactly where it is intended to start installing the plaques that record the names of burials. It was necessary to keep to the same size.
- Need to put a plaque on the stone and an official opening date - Monday 23rd June 2025 was suggested as a possible date for an official opening. This to be discussed again. Signs were also needed to direct people to the Memorial Garden.
- Bench on the site - Elaine Anikey was once again thanked for the kind offer of the Bench. It was suggested that it could be ordered when desired, and installed by the Spring.
- Treating and leveling the land / landscaping - Cllr Rhys Williams said he would spray 'Round-up' there. Regarding planting daffodils - Cllr Alwyn Roberts promised to contact Shan to get the daffodils and arrange to plant them around the site. The Clerk would send a message to everyone to say the time/date.

Following a discussion, and on the proposal of Cllr Eurgain Davies and seconded by Cllr WRP Jones, it was decided that it would not be possible to bury ashes in the Memorial Garden in a specific place, but rather to disperse it on site.

c) Path leading to the playing field - it was agreed that a map should be obtained from the Land Registry, and it was agreed to Shan's kind offer to obtain this for approximately £45.

d) Unclassified road condition from Roslefain in the direction of Ffordd Ddu - the response of the Highways Department of Gwynedd Council was read. On the proposal of Cllr William Davies and seconded by Cllr Eurgain Haf, it was agreed with the suggestion to have an Order to temporarily close the road to traffic for 18 months.

e) Representative of One Voice Wales - agreed Cllr. Lona Harris to this, and the Clerk would let them know.

f) Complaints that the hedge is on the left side of the road when traveling into Lanegryn from the A493 highway, which is opposite the school entrance towards the Maesegryn estate entrance - it was noted that this has been done.

5. Planning Matters

One application had been distributed since the last meeting, namely;

Erection of a roof over an existing agricultural yard and erection of a leaf store in Nant y Cynog, Llanegryn

NP5/64/86G and NP5/64/86H

It was confirmed that there was no objection.

6. Finance Matters.

a) Accounts 2023-24 – there was no further developments.

The Clerk confirmed that the first part of the application for a VAT refund had been made, and that £3103.20 had been received. The VAT claim on the second part of GT Davies & Co's payment had now been sent.

b) Invoices to be paid.

- Council Insurance – Zurich - renewal date 2.12.24. On the proposal of Cllr Catrin Rutherford and seconded by William Davies it was agreed to pay the sum due of £280. All the insurance documents had been sent to the Councilors on 18.11.24 giving full information about the 'cover' that the Council has. The Clerk was asked to try to get the cost of adding the Memorial Garden to the policy.

- On the proposal of Cllr Catrin Rutherford and seconded by William Davies it was agreed to pay £30 to Cllr Eurgain Haf, which was the cost of the flowers for Shan at the last meeting.

c) Consider any requests for money

- Wales Air Ambulance - it was decided not to contribute for the time being.
- The Urdd - To Fund Appeal with Opportunity for Everyone - it was decided not to contribute.

d) It was discussed if any Councilor wished to claim expenses/costs for 2024-25, and everyone was unanimous that they did not want to claim.

e) A draft budget for the financial year 2025-26 was considered, and agreed with minor changes being made.

On the proposal of Cllr William Davies and seconded by Cllr Rhys Williams, it was unanimously agreed to raise the £700 precept for 2025-2026 (to a total of £7850).

7. Correspondence.

a) One Voice Wales training dates - the Clerk would distribute them.

b) One Llais Cymru and the SLCC conference on the 20th of November - the Clerk said he was taking part in this on zoom. On the proposal of Cllr William Davies and seconded by Cllr Rhys Williams it was agreed to pay a quarter of the cost - which is £19 (as the Clerk is responsible for 4 Councils)

c) Llanystumdwy Community Council's correspondence regarding the Report of the Welsh Communities Commission - the Clerk would distribute it.

d) A letter from the Plas Tanybwllch Rescue committee asking for support - it was seen that this was outside our area, but we should wish them well.

e) A consultation was noted by Gwynedd Council regarding the Community Boundary Survey.

8. Any other matter.

There was no other issues.
