  - Yswiriant dros ymddiriedolwyr y Neuadd (sef y Cynghorwyr) - nododd y Clerc ei fod wedi ymholi, ac y byddai rhaid i hyn ddod o dan yswiriant y Neuadd.
- ##### **b) Gardd Goffa – adroddwyd am y datblygiadau yn ddiweddaraf, a thrafodwyd y canlynol;**
- Diolchwyd i bawb ddaeth i blannu y daffodils.
  - Adroddodd y Clerc e-bost at Mr W Willimas – Wynne, ac y byddai yn ymweld ag ef cyn y cyfarfod nesaf. Hefyd e-bost gan Elaine Anikey yn cadarnhau fod y fainc wedi ei harchebu.

## **DYDDIAD CYFARFOD NESAF; Y NEUADD, LLANEGRYN NOS FAWRTH 4ydd Mawrth 2025, 7.30y.h.**

Minutes of a Council Meeting held on Monday evening, January 27th 2025 at 7.30pm in the Hall, Llanegryn.

Present; Cllr. Alwyn Roberts, William T Davies, Eurgain Haf Davies, WRP Jones, Rhys W Williams, Beth Lawton (Gwynedd Council) and Huw T Jones (Clerk)

1. A warm welcome was extended to everyone by Chairman Alwyn Roberts.

There were apologies from Cllr Lona Harris and Catrin Rutherford.

Expressions of interest were invited for issues on the agenda. There were no statements.

2. Presentations by members of the public on an issue on the Agenda.

No members of the public were present.

3. The minutes of the meeting held on the 18th of November were confirmed on the proposal of Cllr Eurgain Haf and seconded by Cllr WRP Jones.

4. Matters arising and other matters.

a) Llanegryn Hall,

- Community Council material in the files in the Hall - noted Kate Cope's email 3.12.24. It was seen that the material needed to be preserved, and Cllr Eurgain Davies promised to deal with this.

- Hall Accounts had been distributed to everyone, noted Heather Black's email dated 15.12.24

- Insurance for the trustees of the Hall (for the Councillors) - the Clerk noted that he had enquired, and that this would have to be covered by the Hall's insurance.

b) Memorial Garden - the most recent developments were reported, and the following were discussed;

- Thank you to everyone who came to plant the daffodils.
- The Clerk reported an email to Mr W Willimas – Wynne, and that he would visit him before the next meeting. Also an email from Elaine Anikey confirming that the bench has been ordered.

- Official opening - Monday evening the 23rd of June 2025 was confirmed as the date for the official opening. On the proposal of Cllr WRP Jones and seconded by Cllr William Davies, the name of Mr W Williams Wynne was agreed to be opened. The Clerk would mention it to him. Need to invite a number to the opening including Spencer Pughe.

- A sign on the stone - it was noted that a simple A4 sign 'GARDD GOFFA LLANEGRYN; AGORWYD 23.06.25'

The Clerk would contact I B Willams and son, Llanbrynmair for a price.

- Signs to direct people to the Memorial Garden - the Clerk would mention this to Elaine Anikey as a representative of the Friends of the Church.

- It was necessary to sow seeds/ get turf - Cllr Eurgain Davies promised to inquire about prices etc.

- Burial of ashes - burial sites etc were discussed - Cllr Beth Lawton would speak to Llinos from Gwynedd Council.

- Tenders for the work of the Memorial Garden - the Clerk noted that proof was needed that a public advertisement had been made, and whether other tenders were available. ( ie for Audit ) He had already written to Shan and Spencer Pughe, and the replies were read.

- It was necessary to put down £30k as the value of the Memorial Garden on the asset list. Also make a risk assessment - Clerk to organize this.

b) Path leading to the playing field - it was necessary to consider Shan's kind offer to get the Land Registry plan for around £45.

c) Condition of an unclassified road from Roslefain in the direction of the Ffordd Ddu - the request was noted for an Order to temporarily close the road to traffic for 18 months. This had not been done, and a reminder was needed.

## 5. Planning Matters

There were no planning applications since the last meeting.

## 6. Finance Matters.

a) Accounts 2023-24 - it was noted that correspondence from Audit Wales confirmed that all the work with accounts 23-24 had been completed, and that a copy of the notice and the Annual Return had been placed on the notice board and the website. Content noted.

b) Invoices to be paid.

On the proposal of Cllr Rhys Williams and seconded by Cllr Eurgain Davies, the following payments were agreed

- HG Web designs - website maintenance - £275
- Jones & Jones invoice for annual maintenance of paths and provision of 2 Christmas trees - £720.

(in relation to this, the Clerk noted that he had sent an invoice for £188, which is the annual reimbursement from Gwynedd Council in this connection)

- Clerk's third quarter remuneration - £400.01 and HMRC payment £100.

c) Consider any requests for money

On the proposal of Cllr Rhys Williams and seconded by Cllr Eurgain Davies, the following payments were agreed

- Llanegryn Cathedral Eisteddfod - £150 (Declaration of interest received from Cllr William Davies and WRP Jones)
- Wales Air Ambulance - an update was received about the Judicial Review, and that a further report is expected on the 7th of February. We could consider next time

e) Following the discussion, it was unanimously decided to make the following changes with the bank accounts. (Cllr William Davies promised to be in charge of this)

7. Correspondence.

a) Un Llais Cymru training dates - the Clerk would distribute them when the latest ones are available.

b) An email from Ieuan Wyn from 'Cylch yr Iaith' was noted encouraging the Council to send a word to Mark Drakeford in the Welsh Government regarding the recommendations of the Welsh Communities Commission. The Clerk promised to distribute them..

c) We noted correspondence from 'Friends of Llyn' inviting us to adopt a language policy. The Clerk would distribute it.

d) Liz Saville Roberts' letter regarding the responsibilities of elected members of the Westminster and Cardiff Parliaments was noted. Also the issues of changing analogue phone lines to digital lines from 31.1.27, that there must be mobile signal technology for 'smart meters' to work and issues relating to energy poverty and pension credit. These would be on the agenda next time.

8. Any other matter.

- Cllr Beth Lawton (Gwynedd Council) reported on the latest regarding Ysbyty Tywyn, including the 'hospital equipment fund' and figures for the minor injuries unit. The services available were listed, and the dedication of the staff there was praised,
- Also noted was an early meeting in relation to mention of proposed cuts in Gwynedd Council, and a meeting of the Scrutiny Committee (Care) which was Chaired by Cllr Beth Lawton who dealt with Health, and invited ideas/comments.
