LLANEGRYN COMMUNITY COUNCIL

Minutes of a Council Meeting held on Tuesday 27th August 2024 at 7.30pm in the Hall, Llanegrynn.

Present; Cllr. Alwyn Roberts, Lona Harris, William T Davies, Catrin Rutherford, Eurgain Haf Davies and Huw T Jones (Clerk)

1. A warm welcome was extended to everyone by Chairman Alwyn Roberts.

An apology was received from Cllr WRP Jones.

Expressions of interest were invited for issues on the agenda.

There were no statements.

2. Presentations by members of the public on an issue on the Agenda.

No members of the public were present.

3. The minutes of the Annual Meeting held on the 20th of May were confirmed on the proposal of Cllr. Lona Harris and seconded by Cllr Eurgain Davies.

4. Matters arising and other matters.

a) Memorial Garden - it was reported that there had been no developments recently, and it would have to be discussed at the next meeting. Following payment of the part payment to GT Davies & Co, it was noted that it would be possible to apply for a VAT refund. Cllr Lona Harries would make inquiries about the kind offer of a bench for the site.

b) Toilets in Llanegryn - a response from Scrub and Dub explained the invoice for £150.00. On the motion of Cllr W T Davies and seconded by Cllr Eurgain Haf Davies, it was decided to pay it. It was decided that the Scrubadub service was not needed in the future. Shan Jones had offered to take care of cleaning the toilets himself, and we were very grateful for this. It was noted that the costs would have to be met every quarter.

c) Path near Peniarth Uchaf - it was discussed that a path through Dysefin farm was in question, and that this was not within the boundaries of Llanegryn Council.

d) Unclassified road condition from Rhoslefain in the direction of the Ffordd Ddu - there was no further response

e) Concern about the new road in Machynlleth - the A493 joining the A487 - reference was made to the response of Llinos Jones from Gwynedd Council regarding this matter.

f) Vacant seat on the Council - it was noted that the public notice inviting application for an election had been on the notice board and the website. An email from Huw Elfed Roberts, Electoral

Services Officer from Gwynedd Council dated 23 August confirmed that no application had been received. The Council could now proceed to co-opt. Posters had been prepared for the notice board, and placed on the website, with a closing date of 27th September. It was noted that two names were already in hand.

6. Finance Matters.

(it was noted that an explanation was needed about the delay in receiving these invoices from Audit Wales).

- c) There was a request from Cerebral Palsy Cymru, and it was decided not to contribute.
- d) There was a note of thanks from Papur Bro Dail Dysynni for the contribution of £150.
- e) The Community Council's HSBC Bank Mandate was discussed - and the need to update. Cllr Catrin Rutherford was thanked for contacting the bank. It was decided to discuss after co-opting the new member of the Community Council.

7. Correspondence.

- a) Reference was made to the One Llais Cymru training dates which had been circulated to the Councillors
- b) Gwynedd Council's consultation on changing the Council's internal voting system was noted and explained.
- c) There was a letter from Gwynedd Council stating work on Pont Dysynni.

8. Any other matter.

- There was a request from a member of the public to investigate the situation of overgrown trees above the path that leads to the playing field. The Clerk would put this on the agenda for the next meeting.
- Everyone expressed sincere thanks to Shan for all her work as Clerk, and also for the work that Shan had done since officially giving up his position as Clerk at the end of March this year. It was seen that a contribution of £300 should be given to her, and this was proposed by Cllr Lona Harries and seconded by Cllr Eurgain Davies, and with everyone's support. Huw would contact the accountant to get confirmation of how to make the payment. Eurgain also agreed to arrange to have flowers by the next meeting on the 30th of September.
