1. Derbynyd y Cofnodion am Mis Medi, gen L.Harris ac ei eilio gen C.Rutherford. The minutes from September meeting were passed by L.Harris and seconded by C.Rutherford.
2. Derbynyd ymddheuriad gen ein Cadeirydd A.Roberts. Apologies was sent from our Chairman A.Roberts.

3. Precept 2024/25

Costau 2023/24 hyd yn hyn yn rhywbeth yn debyg i'r flwyddyn cynt, er fod na swm syweddol tu cefn gen y Cyngor, mae'n debyg fydd hwn wedi ei wario ar project yr eglwys, sydd ar f'yn cychwyn diwedd Mis Mawrth. Fe ddaeth sawl cost ychwanegol i'r fei, sef codi cyflog y Clerc a costau, mewn gobaith o cael Clerc newydd. Costau hyfforddiant i'r Cynghorwyr, costau cynnal a chadw llwybrau a trin sietynoedd yn cynnyddu flwyddyn ar flwyddyn a chostau cynnal a chadw y Toiledau yn cynhyddu hefyd. Felly ar sail y feithiau yma penderfynnwyd I

codi Precept at y flwyddyn 2024/25 deg y cant eleni a gofyn am swm o £6600.00 sef £600.00 yn fwy na llynedd i helpu gyda costau syn cynhyddu o hyd. The cost for 2023/24 are like the previous year, and although the Council do have a considerable sum of money behind them, it is likely that this will all be spent on the Church Project which is to start at the beging of this March. Many extra costs came to light when the Precept was discussed, increasing the wages and cost of the Clark, in hope of appointing a new Clark. The increasing cost of general maintenance of the local footpaths and hedges in the ward, ongoing training for the Councillors and the ever-increasing costs of maintaining the local toilets. Based on this information it was decided by the Councillors to increase the precept this year by 10%, £600.00 more than last year.

4.Eglwys / Church
